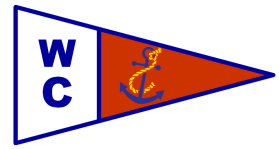


**West Channel Yacht Club**

Docking member must also indicate the services they desire in addition to membership ( i.e. dock installation, and dockage. All members are responsible to acquire their own River Sticker.)

Existing members must sign and submit this form by January 1st to ensure membership is retained and the desired services are provided (especially dockage for this form is used to Plan Dock Location and Installs). In consideration of like payment of other members of West Channel Yacht Club, I do hereby agree to pay the total dues, services and fees shown above for calendar year 2026.

In consideration of West Channel Yacht Club furnishing me with dockage privileges and club facilities at 35817 Lakeshore Blvd, Eastlake, Ohio 44095. I agree to carry Liability and Property Damage Insurance on my watercraft(s) and dockage area in an amount NOT LESS THAN \$100,000 and agree to furnish acceptable evidence of insurance yearly with no exception and add the AI Endorsement to Vessel Insurance policies for WCYC. In addition, all trailers require the owners name to be visible for identification and trailers/watercraft must be registered. I further agree that my guests visiting at said club facilities will be my responsibility and that I shall hold West Channel Yacht Club harmless from any and all suits that may arise as the result of any actions on the part of myself and/or my guests.

In further consideration of like actions by the members of West Channel Yacht Club, I agree that I will have my boat either in the water or in a summer storage area designated by the club no later than June 15th. In the event I have not complied with any provision of this contract, then I waive all further notice by the club and assign to the said club the right to move my boat to a said storage area and further agree to become personally liable for any and all costs of said removal. Furthermore, I include the right of the club to place a lien against my boat if I should fail to pay any of the dues or other charges.

I hereby agree to abide by all requirements of West Channel Yacht Club.

**Caution: Upon signing this agreement, members purchasing dockage services commit to 50% of the member dues, dockage services and house/grounds maintenance.**
